FINAL WORD

When we renovated Begginnings we designed several spaces within our one concept each with the drive to create memorable experiences for our guests.

Our space features a dining room with an assortment of plush leather booths, optimally spaced out tables enclosed by well defined sections decorated with hanging lights, separating walls adorned by a host of plants and a couple of superb freshwater fish tanks. This dining room is accompanied by a comfortable lounge area sitting underneath a magnificent set of four wooden rafters built underneath a 20ft ceiling. Our lounge area sits directly in front of our 40ft long fully equipped bar for every need, embellished by copper sheet metal contrasted by dark stained wooden beams, accomplishing a sensational rustic bar in the centre of our restaurant .

TERMS & CONDITIONS



Deposits

A minimum nonrefundable deposit of 10% (minimum \$250) of your event package is required at the time of reservation of an event. Depending on services required, however, a nonrefundable deposit of 50% or more of the total package price may be required. The remaining balance is due 14 days prior to the scheduled date.

Cancellations and Refunds

In the event of a cancellation a \$250 nonrefundable administrative fee will be retained from your deposit (additional nonrefundable cancellation fees will apply where a third party reservation is involved). Any remaining deposits that were paid will be refunded if written notice of cancellation is received prior to 30 days leading up to your scheduled date, after this time has elapsed, all deposits that were given to Beginnings shall become nonrefundable.

Cancellations with Third Party Involved

Regardless of the requirements for a refund having been fulfilled as defined above, any deposits paid to Beginnings that, on your behalf, were disbursed to a third party for the purpose of reserving or acquiring a particular service, such as equipment rental, table settings, or any other service or facility will be nonrefundable if a cancellation occurs irrespective of when notice of cancellation is given. This is as the refund policy of the third party will, at least in part, supplant our refund policy, which generally stipulates relinquishment of all payments made to them on your behalf.

Termination Clause

Beginnings is not responsible for cancellations due to unforeseeable events that are beyond either our clients or our own control. This may include weather-related incidents, a government shutdown, a pandemic, third party cancellations or any other unforeseeable circumstance leading to us being unable to go through with our planned event.

Indemnification Clause

Our clients are solely responsible for the maintaining the integrity of all equipment sourced from third parties and any damages sustained to rented equipment will be solely liable to the client.

Venue Damages

Our clients whom our booking events with us are solely responsible for damages made to any of our venue structure or equipment by themselves or any of those who attend their events. Any costs associated with these damages will be charged to our client.

Photo Release Clause

Unless specified prior to the event Beginnings reserves the right to use and edit photos taken of all our events to be used for promotional material for future events. If our clients wishes for us to not use photos for these purposes please state so prior to your event and we shall happily respect this request.
